ORDINANCE OF THE OGLALA SIOUX TRIBAL COUNCIL AMENDING PARTS 2-8 OF CHAPTER 44 OF THE LAW AND ORDER CODE TO CHANGE THE "FILING OFFICE" FOR DOCUMENTS AND FEES TO THE OST REVENUE OFFICE.

WHEREAS, the Oglala Sioux Tribe has adopted its Constitution and By-Laws by referendum vote on December 10, 1935, in accordance with Section 16 of the Indian Reorganization Act of 1934 (25 U.S.C. §476), and under Article III of the Oglala Sioux Tribe Constitution, the Oglala Sioux Tribal Council is the governing body of the Oglala Sioux Tribe, and

WHEREAS, the Oglala Sioux Tribe did adopt Ordinance No. 07-25 on July 30, 2007, approving and adopting the Oglala Sioux Tribe Secured Transactions Act, codified as Parts 1-9 of Chapter 44 of the Law and Order Code (the "UCC"), and

WHEREAS, the OST Revenue Office is the office the Tribe best suited and authorized to accepted payments and filing of documents under Parts 2-8 of the UCC, and

WHEREAS, a Schedule of Fees to be charged for such business filings is necessary and appropriate to notify the public of amounts to be charge by the Tribe for business filings, and

WHEREAS, it is proposed that Parts 2-8 of the UCC be amended to make the OST Revenue Office the "Filing Office" under such Parts and that a Schedule of Fees be adopted that increases the Tribe's revenue as a result of such business filings, now

THEREFORE BE IT ORDAINED, that the implementing amendments to Parts 2-8 of the UCC shown in the attached EXHIBIT a - IMPLEMENTING AMENDMENTS TO UCC, are hereby approved and adopted in all respects and that the UCC (Parts 2-8) is hereby amended to include the amendments shown in EXHIBIT A hereto.
